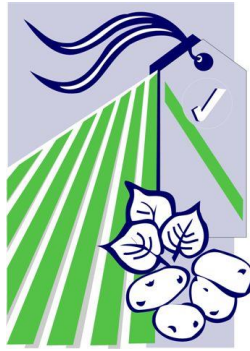

1. Isethulo

1.1 Leli Bhukwana, kuhlangukisa nefomu elinqunyiwe kanye nezimali ezinqunyiwe okumayelana nesicelo sokuthola ulwazi, kulungiswe futhi kwashicilelwa Insizakalo Yokuqinisekiswa Kwamazambane (Inombolo Yokubhaliswa: 1995/005404/08 ("PCS")) ngokulandela izidingo Zesigaba 14 soMthetho Wokukhuthazwa Kokufinyelela Olwazi (2000), onguNo. 2 ka 2000 ("uMthetho"). Inhloso yalo ukwenza kube lula ukufinyelela kumarekhodi asezandleni ze-PCS ukuze kuhlangukatshezwane nezinhloso zoMthetho. UMthetho ubalula izindaba ezithinta inqubo edingekayo mayelana nalezi sicelo

Ukukhokhela lawa marekhodi kumele kwenziwe kubhekiswe kwi-PCS ngaphambi kokuba kwenziwe isicelo sokufinyelela kumarekhodi.

1.2 Ngaphezu kwamagama achazwe kwezinye izigatshana, lawa magama alandelayo ayoba nalezi zincazelo ezilandelayo kuleli Bhukwana: -

1.2.1 **"Isikhulu Esihlinzeka Ngolwazi"** kuyobe kusho isikhulu esiphezulu jikelele, noma isikhulu esisesikhundleni esifanayo, kwa-ICCSP noma umuntu olibamba kulesi sikhundla;

1.2.2 **"Isekela Lesikhulu Esihlinzeka Ngolwazi"** ikuyobe kusho lowo muntu/labho bantu abaqokwe ngokwemibandela Yesigaba 17 soMthetho;

1.2.3 **"Ibhukwana"** kuyobe kusho leli Bhukwana ngokuhlanganyela nazo zonke izinto ezinanyathisiwe kulo elitholakala emahhovisi e-ICCSP ngezikhathi ezahlukene;

1.2.4 **"I-SAHRC"** kuyobe kusho ukuthi i-South African Human Rights Commission.

2. Ukuma kohlaka kanye nemisebenzi ye-PCS (Isigaba 14(1) (a) soMthetho)

2.1 Ngomhla ziyi-15 kuNhlaba 1998 uNgqongqoshe Wezolimo, esebenza ngaphansi Kwesigaba 23 soMthetho Wokwenza Ngcono Izitshalo, onguNo. 53 ka 1976 ("uMthetho Wokwenza Ngcono Izitshalo"), wasungula isikimu esaziwa ngokuthi Isikimi SaseNingizimu Afrika Sokuqinisekiswa Kwamazambane (i-South African Seed Potato Certification Scheme) ("Isikimu") wabe eseqoka i-ICCSP ukuthi kube ziyona ezokwengamela ngamandla, yenze imisebenzi iphinde iqhube izimfanelo ethweswe zona, ezinikeziwe noma ezingaphansi kwe-ICCSP ngaphansi Kwesikimu.

2.2 I-ICCSP, ngokwemibandela Yesigaba 24(2)(a) soMthetho Wokwenza Ngcono Izitshalo, yaqoka i-Potato Certification Service NPC (inombolo yokubhaliswa: 1995/005404/08) ("PCS"), ukuthi yenze, igcine futhi iqhubeke namandla, nemisebenzi kanye nezimfanelo ze-ICCSP. Ngomhla 23 Okthoba 2012 i-ICCSP kanye ne-PCS benza Isivumelwano Sokuletha Intuthuko.

2.3 I-ICCSP iyilokhu esikubiza ngokuthi *"inyhlangano yomphakathi"* njengalokhu ichaziwe Kwisigaba 1 soMthetho, kwazise i-ICCSP inamandla omphakathi futhi yenze imisebenzi ngokulandela imigomo Yomthetho Wokwenza Ngcono Izitshalo. I-PCS nayo iyinyhlangano yomphakathi ngokwezinhloso zoMthetho njengalokhu i-PCS ingumhlinzeki ngezinsizakalo oqokiwe, futhi igcina amarekhodi eSikimu.

5.2 Ulwazi kumele lucelwe ngokusemthethweni (ISIGABA 14(1)(d) soMthetho)

I-PCS igcina amadokhumenti kanye nolwazi olubalulwe Kwisheduli engezansi, nangatholakali ngaphansi kukapharagrafu 5.1 kanti phela lawo madokhumenti kanye nolwazi lolo kusuke kufanele ukuthi kucelwe ngokusemthethweni kwa-PCS ngokulandela izimiso zoMthetho. Ukukleliswa kwesihloko esithile noma komkhakha wamarekhodi athile akumele ukuthi kuhunyushwe njengokuthi amarekhodi angaphansi kwalezo zihloko noma/kanye kwaleyo mikhakha kuyokwenza ukuthi kutholakale ngaphansi koMthetho. - 6.1 Sebenzisa ifomu elinqunyiwe lakwaPCS okunguFomu A Lokucela Ukufinyelela Kumarekhodi Esikhungo Somphakathi ashicilelwa mhlaka 15 Febhuwari 2002 Kwigazethi Kahulumeni ngokwemibandela Yesigaba 18(1) soMthetho njengalokho OKunanyathiselwe B Kwisaziso R187. IFomu A linanyathiselwe khona lapha laba uSheduli 1.
- 6.2 Umfakisicelo kufanele ukuthi futhi akhombise ukuthi ngab isicelo leso singesekhophi yerekhodi noma ngabe umfakisicelo ufuna ukulibona nje irekhodi leli emahhovisini e-PCS ngokwendlela eshiwo Kwisigaba 29(2) soMthetho.
- 6.3 Umfakisicelo uyobe esenikwa ilungelo lokufinyelela kwirekhodi lelo ngendlela leyo ayobe yena ecele ukufinyelela ngayo, kodwa lokho kuhambisane nemibandela Yesigaba 29(3) kanye no (4) koMthetho. Uma indlela okucelwe ukuthi kufinyelwe ngayo kwirekhodi iyophazamisana ngokungaphusile nokusebenza okufanele kwe-PCS, kulimaze ukongiwa kwerekhodi noma kubonakale sengathi kuphambene nomthetho amalungelo obunikazi obungesibo obe-PCS, ukufinyelela kulelo rekhodi kunganikezelwa ngenye indlela. Imali eyobizwa ngalokho angake ibe ngaphezu kwemali umfakisicelo abeyobizwa yona ukuba ubenikwe irekhodi ngendlela abecele ngayo.
- 6.4 Uma umfakisicelo efisa ukwaziswa ngokwemibandela Yesigaba 18(2)(e) soMthetho ngesinqumo ngesicelo ebesenziwe ngaphezu kwempendulo ebhalwe phansi, ngenye futhi indlela, leyo ndlela-ke kanye neminingwane yakhona efanele kuyomele ukuthi kushiwo.
- 6.5 Uma isicelo senziwa egameni lomuntu, ubufakazi bokuthi lowo owenza leso sicelo usenzela omunye kufanele ukuthi bulethwe ngokwemibandela Yesigaba 18(2)(f) soMthetho ngendlela ezokwenelisa Isikhulu Esihlinzeka Ngolwazi ngokuphusile.
- 6.6 Isigaba 18(3) soMthetho sihlinzeka ngokuthi isicelo esenziwe ngumuntu phaqa egameni lakhe okuthi ngenxa yokungakwazi ukufunda nokubhala noma ngenxa yokukhubazeka angakwazi ukufaka isicelo, ukuthi lowo muntu isicelo sakhe asenze ngomlomo. Isikhulu Esihlinzeka Ngolwazi kuyoba yisiona esiyobe sesikuthatha konke lokho okuyisicelo esenziwe ngomlomo sikubhale phansi kwifomu lakhona elifanele bese sihlinzeka umfakisicelo ngekhophi yalelo fomu.
- 6.7 Izimali zokukhokhela izicelo zokufinyelela kumarekhodi ziyobizwa ngokulandela Isigaba 22 soMthetho. Uhlelo lokuma kwezimali eziyobizwa luhambisana nalokhu Luwusheduli 2.
- 6.8 I-PCS iyaligodla ilungelo layo lokubiza enye imali eyengeziwe ngolwazi lwayo olungekho kwinqolobane yolwazi lwayo.
